- xvi. To promote and carry on research in diseases and to promote educational research of innovation, experimental, preventive curative, rehabilitative and demonstrative kinds on various diseases prevalent among the people.
- xvii. To establish, build, maintain, run and / or render financial assistance to hospitals, surgical homes, health clinics, nursing homes, dispensaries, homes and schools for the old, disabled, handicapped and blind persons and institutions of medical research or education and surgical treatment, care, cure, recuperation and other advantage to alleviate the sufferings of the handicapped.
- xviii. To recruit, train and provide or to assist in recruitment and training medical and other staff for any such institution.
- xix. To equip any of the institutions referred to above with necessary beds, machinery, equipment, accessories and instruments etc., and to provide for medical aid, glasses and food in such institutions to deserving and needy patients.
- xx. All additions, acquired or gifted from time to time, voluntary donations, gifts, legacies or grants in cash or in kind to be accepted by the TRUSTEES.
- xxi. It is specifically stipulated that the activities of the trust would be purely of charitable nature and not motivation for profit.
- e) The founders of the Trust shall be in charge of the entire administration of the Trust.
- f) For the management of the Trust it will be open to the founders of the Trust to co-opt other persons for such period as the founders of the Trust may determine.
- g) It will be open to the founders of the Trust to nominate any person or persons as their successors or revoke such nominations and substitute another person or persons. Such person or persons so nominated shall be entitled to provide for the future administration of the Trust.
- h) The Trustees reserve to themselves the power to enlarge the scope of the Trust. But such powers shall be exercised only in such manner as not to disturb the character of the trust as a Charitable Trust. The Trustees also reserve to themselves the power to provide a new scheme for management of the Trust.

1. The purpose of this document is to provide information regarding the activities of the Trust and its subsidiaries.

2. The Trust is a non-profit organization established for the purpose of promoting the welfare of the community.

3. The Trust is organized under the laws of the State of New York.

4. The Trust is a corporation with a board of directors and a president.

5. The Trust is a charitable organization and is exempt from federal income tax.

6. The Trust is a public charity and is subject to the provisions of the Internal Revenue Code.

7. The Trust is a non-exempt charitable organization and is subject to the provisions of the Internal Revenue Code.

- i) No alteration shall be made to the Trust Deed, which for the time being in force unless the alteration has been previously submitted to and approved by the Director of Income - Tax exemptions.
- j) The funds and income of the Trust shall be solely utilised towards the objects of the Trust and no Portion of it shall be utilised for payment to Trustees or person defined in section 13(1)(c) of the Income Tax Act by way of profit, interest, dividend etc.
- k) Not more than 5% of the Income of the Trust would be applied for any religious purposes or given to religious institutions.
- l) The funds of the Trust shall be invested in the modes specified under the provisions of section 13(1)(d) read with section 11(5) of the Income Tax Act 1961.
- m) True accounts shall be kept of all sums of money received and expended by the Trust and the matters in respect of which such receipts and expenditure take place and of the property, credits and liabilities of the Trust. The accounts of the Trust shall be examined and the correctness of the balance sheet and income and expenditure account ascertained by a properly qualified auditor.
- n) If upon winding up or dissolution of the Trust, there remains after the satisfaction of all the debts and liabilities, any property whatsoever, the same shall be transferred to such other Trust having objects similar to the objects of the Trust to be determined by the Trustees at or before the time of dissolution.
- o) It is hereby expressly declared that the Trust created hereby is irrevocable and that no donation shall be made outside India.
